WBIF 1st Strategic and Operational Board Meetings

On 16 and 17 December, the Western Balkans Investment Framework (WBIF) held its first meeting of the Strategic and Operational Boards. Over 120 participants attended, including representatives from 27 EU Member States, the European Parliament, representatives of the Western Balkan partners, Norway, Financial Institutions (EIB, EBRD, CEB, KfW, WBG, AFD, EIF and IFC), and the Energy Community Secretariat.

Start of Works on the EU-supported Corridor Vc

Section near Doboj

At the end of November, works started on Corridor Vc section from interchange Rudanka to the exit tunnel Putnikovo brdo 2, another important part of the Corridor Vc in Bosnia and Herzegovina. This section crosses entity border in the middle of a tunnel Putnikovo brdo 2 and is an example of a successful cooperation between the public companies of both entities - Federation of BiH and Republika Srpska.

Zenica Tunnel on the Corridor Vc Fully Drilled

In November, workers of the Sarajevo-based company "Euro-Asfalt" broke the left pipe of the "Zenica" tunnel on the Ponirak-Vraca section of the road Corridor Vc in Bosnia and Herzegovina. The first, right pipe of this tunnel near Zenica, in the length of 3.4 km, was drilled earlier in November.

Additional €5 million for Počitelj-Zvirovići Section of Corridor Vc

The European Investment Bank (EIB) and the Ministry of Finance of Bosnia and Herzegovina signed an agreement in November for a €5 million EU grant for the supervision of construction works for the Počitelj-Zvirovići subsection of Corridor Vc. Once completed in 2022, it will provide approximately 21 km of continuous motorway between Počitelj and Bijača on the southern border of Bosnia and Herzegovina with the European Union in Croatia.

EU Support to the Deployment of Next Generation Networks in Montenegro

The European Union funds the development of broadband infrastructure in Montenegro with technical assistance grant of €550,000, which shall improve the coverage of the territory with infrastructure for fixed internet.
